
#### BLUEBILL FOOD BANK PROJECT

Later in April 1998, we were interested in expanding the membership. We requested and were given a list of retirees from the Community Relations Dept (CRD). The list was ten years old, by zip-code. Boeing was very reluctant to provide useful information on retirees. We began calling retirees from the list. After ten years: some of the phones were no longer valid; the zip-codes were not reliable, etc.

As I mentioned last time, John Luebke was assigned to be a liaison between Boeing and ourselves. He tried very hard to be helpful, but was continually stalled by the CRD.

Myron Vogt made a small, but effective, sandwich board sign which was used to identify Olympic Peninsula Bluebill (OPB) activities. The sign is still in use. We received from Boeing, via, one of the Seattle chapters, a 34x46 nylon Bluebill banner which is being used at our social functions.

It should be noted that we were the first Chapter seeking approval whose organization was outside of Boeing facilities. Boeing wasn't quite sure how to deal with us.

There were reams of e-mails, phone calls, etc between John and myself to come to an agreement between CRD and ourselves. We had little if any negotiation leverage.

Because of the lack of financial support from Boeing, I was tempted to separate our relationship from Boeing and apply for a non-profit status and establish a fund raising operation.

### What-the-heck is the Olympic Area Agency on Aging? (aka OAAA, O3A)?

Back in the '60's, the Older Americans Act mandated the creation of Area Agencies on Aging nationwide to plan for, contract for, fund and monitor "...services to seniors...", defined as folks 60+.

### OK, then what-the-heck is Senior Information & Assistance (aka I&A, Sr. I&A, SIA)?

The Older Americans Act instructed Area Agencies to create Information & Assistance programs that would guide "seniors" to any service, program and/or resource that could serve them, with the overarching goal of helping folks remain independent in their own homes.

On the Peninsula, O3A is the parent organization for Senior I&A, the folks we know as Jaci, Heaven, Sina, Mark & Drew. They work with Elders, their families and caregivers to support them in ways that promote choice, independence and dignity, and allow them to live their lives in the most independent ways possible.

One of those ways is by providing "case management" services to folks who are sufficiently "low income" to qualify for Medi<u>caid</u> and sufficiently impaired in their abilities to live independently that they actually "qualify" to be in nursing homes! - But, have chosen to remain at home.

The ramps, grab bars and other environmental modifications that the Bluebills provide to these folks through I&A are <u>vital</u> to their ability to stay at home - The best "help" in the world can't keep a person functioning in a "hostile" environment. As one might expect, given that Medicaid is "government finds," the funds are inadequate to really get the job done, so without the Bluebills, what would happen?

Not much - Not near enough. So I wanted to be sure to say, **Thank you** 

And one more thing: I&A doesn't just serve "low income" folks - It provides a wealth of information, education and "guidance" on just about any aspect of Aging in America, from Advance Directives to Durable Powers of Attorney, so don't be afraid to call with your own questions, or to refer a friend. - FROM MARK HARVEY


